**Terms and conditions of the promotion**  
**"Summer promo"**

**I. Introductory provisions**

1. These terms and conditions (hereinafter referred to as the "**Terms and Conditions**") shall determine the terms and conditions of participation in the "Summer promo" promotion (hereinafter referred to as the "**Promotion**") concerning the purchase of services provided electronically within the Internet service made available under the domain of autenti.com (hereinafter referred to as the "**Autenti Platform**").
2. The organizer of the Promotion is Autenti sp. z o.o. with its registered office in Poznań at Św. Marcin 29/8, 61-806 Poznań, entered in the Register of Entrepreneurs kept by the District Court Poznań Nowe Miasto and Wilda in Poznań, VIII Commercial Department of the National Court Register under KRS number 0000436998, holding NIP 783-169-32-51 and share capital of PLN 6,811,700.00 (hereinafter referred to as "**Autenti**"). 3. The Promotion lasts from 30.07.2025 to 05.09.2025.

**II. Terms of the Promotion**

1. The Promotion is addressed to Autenti Platform Customers who are entrepreneurs (hereinafter: "**Participant**") and allows, during the Promotion period, to purchase a one-year subscription to a User account at a discount from the base price for the first subscription period, i.e.:
  - a) PRO Plan of the Autenti Platform for 156 EUR net,
  - b) PREMIUM Plan of the Autenti Platform for 273 EUR net.
2. The Promotion only covers the purchase of subscriptions under the Company Account and applies to Participants who have not yet used the paid plan for the provision of services under the Autenti Platform.
3. In order to use the Promotion, the Participant should:
  - a) log in to their Account on the Autenti Platform;
  - b) click the "Buy now" button and then proceed to the process of purchasing the subscriptions indicated in Section II, paragraph 1 of the Terms and Conditions;
  - c) enter in the designated field one of the promotional codes: WAKACJE35 or HOLIDAY35 or FERIEN35;
  - d) purchase the subscription with the discount resulting from the promotional code.
4. The terms and conditions for the provision of services by Autenti and a detailed description of the functionalities available under the Account and a given subscription are set forth in the Terms and Conditions of the Autenti Platform available at <https://autenti.com/en/terms-and-conditions/autenti-platform-terms-conditions> (hereinafter: "**Autenti Platform Terms & Conditions**") and the price list available at <https://autenti.com/en/pricing/autenti-platform> (hereinafter: "**Price List**"), subject to changes indicated in the text of the Terms and Conditions.

### III. Promotional gadget

1. A Participant who has made a purchase under the Promotion may additionally receive a promotional gadget, subject to the availability of the gadget at the time of application. The right to receive a gadget in connection with the use of the Promotion is valid until the pool of gadgets is exhausted.
2. The list of gadgets available for selection for Participants who have purchased subscriptions indicated in Section II, paragraph 1 of the Terms and Conditions:
  - a) picnic blanket,
  - b) travel pillow,
  - c) solar powerbank,
  - d) backpack
  - e) or a tourist bottle.
3. Autenti will provide information about currently available gadgets after sending an inquiry to [marketing@autenti.com](mailto:marketing@autenti.com)
4. In order to make an application, the Participant, after making a purchase under the Promotion, should send an email to [marketing@autenti.com](mailto:marketing@autenti.com) with information about the purchase made, indication of the preferred promotional gadget and details for shipping the gadget. If the stock of the preferred gadget runs out, the Participant will be able to choose another available gadget.

### IV. Other provisions

1. The Participant undertakes to comply with the conditions specified in the Terms and Conditions. An Entity that does not meet the conditions specified in the Terms and Conditions is not entitled to use the Promotion. In a situation where an existing Participant uses a service or purchases a product in contravention of the provisions set forth in the Terms and Conditions, Autenti shall be entitled to recalculate the prices of the services ordered in accordance with the Price List applicable without the Promotion, or to disable subscriptions purchased in contravention of the Terms and Conditions.
2. Participation in the Promotion and providing personal data related to participation is voluntary.
3. Autenti shall not be liable for any incorrect data provided by the Participant.
4. The administrator of the personal data necessary for the dispatch of the gadget is Autenti sp. z o.o. with its registered office in Poznań, Św. Marcin Street 29/8, 61-806 Poznań. The data will be processed for the duration of the Promotion and the period necessary to handle any complaints, not longer than the expiration of the period of limitation of claims. Recipients of the data may be entities providing logistic or postal services, to the extent necessary to carry out the shipment. The participant has the right to access the content of his/her data, rectification, deletion, restriction of processing, data portability and to object to data processing, as well as the right to lodge a complaint with the President of the Office for Personal Data Protection.
5. Processing of personal data is carried out under the terms of the Privacy Policy, available at <https://autenti.com/en/terms-and-conditions/privacy-policy>.

6. Violation by the Participant of any of the provisions of the Terms and Conditions, in particular submission of false statements, violation of laws or morals in connection with participation in the Promotion, entitles Autenti to exclude the Participant from the Promotion.
  7. This Promotion is not cumulative with other Autenti promotions.
  8. All complaints regarding the way the Promotion is conducted may be submitted by the Participant using the contact form available at <https://autenti.com/en/contact> or in writing to the address of Autenti's registered office indicated in Section I, paragraph 2 of Terms and Conditions. The complaint procedure shall be conducted in accordance with the rules indicated in the Autenti Platform Terms & Conditions.
  9. In matters not covered by these Terms and Conditions, the provisions of Autenti Platform Terms & Conditions shall apply.
  10. Autenti reserves the right to amend the Terms and Conditions to the extent that they do not diminish the rights of Participants who are consumers. Amendments to the Terms and Conditions shall become effective upon announcement on the Autenti Platform, unless otherwise indicated in the announcement.
